# PERKIOMEN TOWNSHIP MUNICIPAL AUTHORITY MEETING: MAY 14, 2024 @ 6:00 p.m.

ARTISAN LAND COMPANY: Jacqueline Erixxon from the Artisan Land Company has asked to come before the Municipal Authority to discuss the matter of sewer capacity for their proposed development located on Bucher Road/Centennial Street. The proposed development is in three municipalities: Perkiomen Township, Schwenksville Borough, and Lower Frederick Township. There are 27 homes being proposed to be built in Perkiomen Township. Ms. Erixxon is requesting consideration by the Authority to allow these 27 homes to opt-out of requiring the public sewer capacity to go into the Oaks Treatment Plant and instead be allowed to let this sewer capacity go into the Schwenksville Borough Authority Sewer System.
