ADDRESS NUMBERS

Are your address numbers visible for emergency services? No one knows when an emergency will occur and having your address visible can save precious time for emergency services in finding your home. Perkiomen Township, through its Property Maintenance Code, requires that address numbers be plainly visible and legible from the street or road fronting the property. The ideal place for address numbers is on both sides of the mailbox or post fronting the property. In cases where there is no individual mailbox, the numbers should be put on an exterior surface on the front of the home or on a stake in the front yard adjacent to the street. Address numbers shall contrast with their background and be of a minimum size of 4 inches in height.



EAC NEWS

Six Simple Actions to Help Birds

- **Make windows safer.** Up to a billion birds die each year from window collisions in the US. Install window screens or break up reflections using film, paint, or string.
- **Keep cats indoors.** Outdoor cats kill over 2.4 billion birds in the US each year.
- **Reduce lawn and plant natives.** Lawns don't offer enough food or shelter for many birds, so plant natives and help provide nectar, seeds, berries, and insects for them.
- **Avoid pesticides.** Common weed killers used around the home can be toxic to birds and wildlife.
- **Reduce your plastics.** Birds can mistake plastic for food or become entangled in it. Avoid single-use plastics and recycle or reuse when you can.
- **Turn off your outside lights.** Light pollution interferes with navigational skills birds and insects naturally rely on.

REIMBURSEMENT FOR DAMAGE TO MAILBOX & POST

Perkiomen Township has adopted a policy regarding the reimbursement for damage to any mailbox and/or post caused by the Township's snowplows. This includes damage caused by Township employees, agents, and contractors that plow snow or salt and cinder the roads in Perkiomen Township. Any mailbox owner that claims a Township plow has damaged his/her mailbox and/or post shall report the damage to Shawn Motsavage, Township Road Master, within five (5) business days. Upon receipt of the claim, Mr. Motsavage will investigate the complaint. The Township shall only be responsible for damage to the mailbox and/or post that it strikes with its vehicles or its plows and shall not be responsible for damage caused by plowed snow, salt, or cinders. The owner of the mailbox shall either repair or replace the mailbox and/or post, then submit a receipt to the Township for the cost. Said receipt shall be submitted with a request for reimbursement within thirty (30) days after Mr. Motsavage has investigated the claim. If the receipt for repair or replacement of the mailbox and/or post is less than \$125.00, the Township will reimburse the owner for the amount set forth on the receipt. If said cost exceeds \$125.00, the Township's financial responsibility shall be capped at \$125.00. The Township's responsibility shall be limited to the cost of the repair or replacement of the mailbox and/or post only. Any other items (e.g. fences, plantings, basketball nets) situated in the right-of-way or the edge of the roadway are placed there at the owner's risk and are not eligible for reimbursement by the Township should they be damaged by the Township's employees, agents or contractors.

Escape Planning

Plan Ahead! If a fire breaks out in your home, you may have only a few minutes to get out safely once the smoke alarm sounds. Everyone needs to know what to do and where to go if there is a fire.

SAFETY TIPS

- » **MAKE** a home escape plan. Draw a map of your home showing all doors and windows. Discuss the plan with everyone in your home.
- » **KNOW** at least two ways out of every room, if possible. Make sure all doors and windows leading outside open easily.
- » **HAVE** an outside meeting place (like a tree, light pole or mailbox) a safe distance from the home where everyone should meet.
- » **PRACTICE** your home fire drill at night and during the day with everyone in your home, twice a year.
- » **PRACTICE** using different ways out.
- » **TEACH** children how to escape on their own in case you can't help them.
- » **CLOSE** doors behind you as you leave.

IF THE ALARM SOUNDS...

- » If the smoke alarm sounds, **GET OUT AND STAY OUT**. Never go back inside for people or pets.
- » If you have to escape through smoke, **GET LOW AND GO** under the smoke to your way out.
- » **CALL** the fire department from outside your home.



FACTS

- ! According to an NFPA survey, only **one of every three** American households have actually developed and practiced a home fire escape plan.
- ! While **71%** of Americans have an escape plan in case of a fire, only **47%** of those have practiced it.
- ! **One-third** of American households who made an estimate thought they would have at least 6 minutes before a fire in their home would become life-threatening. The time available is often less. And only **8%** said their first thought on hearing a smoke alarm would be to get out!

Put a **FREEZE** on Winter Holiday Fires

It's fun to decorate for the winter holidays, but holiday decorations can increase your risk for a home fire. As you deck the halls this season, be fire smart.



Almost half of the home decoration fires in December are started by candles.



Think about using **battery-operated flameless candles**.



Christmas is the peak day for candle fires.



Keep candles at least **12 inches** away from anything that burns.



A dry Christmas tree can burn very hot and very fast.



More than 1 in every 5 Christmas tree fires were caused by a heat source too close to the tree.



Read manufacturer's instructions for the number of light strands to connect.



Make sure your tree is **at least 3 feet away** from heat sources like fireplaces, radiators, space heaters, candles or heat vents. Also, make sure your tree does not block exits.



Get rid of your tree after Christmas or when it is dry.

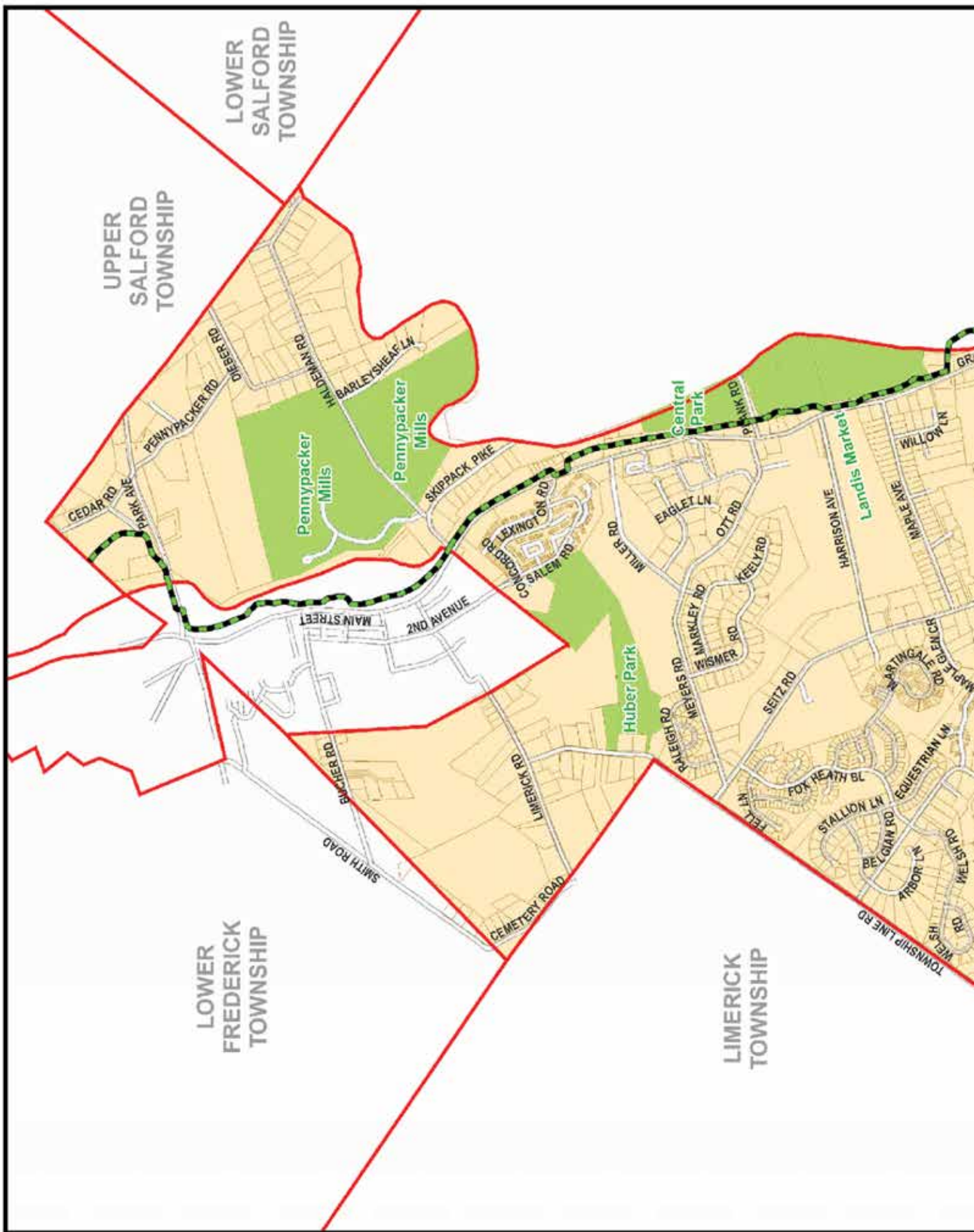

Be Informed, Prepared & Involved - Be Ready

Emergencies and disasters strike quickly and often without warning. They can disrupt our lives, force us to leave our homes, or even confine us for days without essential services like electricity, phones, or water. How ready are you and your family?

Families can, and do, cope with disaster by preparing in advance and working together as a team. Follow the steps listed in this website to create your family's disaster plan. Knowing what to do is your best protection. Be informed, prepared and involved. Are you READY?

One of the first things you can do is sign up for our ReadyMontco notification system. This program delivers alerts about severe weather and other important events in Montgomery County to the devices of your choice. Whether you prefer emails, text messages, or even a phone call - you decide the option that works for you.

There is no direct cost to sign up for ReadyMontco. However, there may be charges for certain features (like receiving text messages) so it's best to double check with your service providers.

This system is administered by the Montgomery County, PA Department of Public Safety

Perkiomen Township has changed the provider for resident notification from Blackboard connect to ReadyMontco. If you have not already signed up for ReadyMontco we are asking all residents to sign up and choose to get alerts from Perkiomen Township. If you have already signed up for ReadyMontco make sure to check your profile and make sure you have chosen to get alerts from Perkiomen Township. Stormwater Pollution Prevention Tips

MANAGING STORMWATER ON YOUR PROPERTY THIS FALL

Fall is here! And with this change in season comes cooler temperatures, shorter days, and lots of yard work to tackle. When crossing off your to-do-list this fall, it's important to remember that yard debris is a significant source of stormwater pollution.

Organic plant material like grass clippings, leaves, and shrubbery trimmings can carry pesticides and fertilizers from your yard and deposit them in local waterways. Piles of leaves and grass clippings will overload a stream's ability to process leaf litter, causing nutrient pollution and oxygen depletion. Yard debris can also clog culverts, storm drains and pipes causing flooding.

Luckily, there are some easy steps that you can take on your property to reduce pollution and improve water quality!

Do not pile leaves or other yard waste near streams or drainage areas where they can blow or wash into creeks. Use designated leaf collection bags for curbside leaf recycling.



Do not blow leaves or grass clippings off of your property into streets, streams, ponds or drainage swales.



Recycle grass clippings and their nutrients by mulching them and leaves into your lawn or piling them in your garden beds. They will add nutrients back into your lawn and provide shelter for wildlife during the winter.



Plant a native tree! Trees provide vital habitat for wildlife and absorb more stormwater than your lawn does.

MELTING SNOW IS STORMWATER TOO!

Stormwater runoff can come in many forms, including snow melt! When the ground is frozen, melting snow can't infiltrate into the soil the way that rain water is able to. This means that even a small amount of snow can cause flooding on your property.

When snow melts, it picks debris and pollutants that make their way into nearby streams and creeks. In the winter, de-icing salts are a main contributor to stormwater pollution, causing detrimental impacts to local wildlife and water quality.

Check out these simple steps that you can take to reduce stormwater runoff on your property this winter!



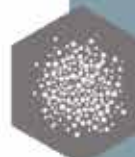

Start shoveling early! The more snow you remove, the less salt you'll need to use.



Pile snow in locations with the most opportunity for it to infiltrate into the ground.



Use de-icing salt sparingly. Follow the product instructions and give it time to work. Sweep up any remaining material.



Clear away any snow that may have been thrown onto storm drains.

PERKIOMEN TOWNSHIP MUNICIPAL AUTHORITY CAUSES OF SEWER BACK-UPS

The Perkiomen Township Municipal Authority continues to spend time televising the sanitary sewer mains in areas of the Township. All too often during this televising, the Township/Municipal Authority finds grease build-up and tree roots in some of the sewer laterals. The Municipal Authority has the responsibility for the maintenance of the sanitary sewer mains while the responsibility to maintain the sewer laterals belongs to the property owner.

One of the main causes of sewer blockages is grease in the sewer laterals and sewer mains. Do not pour grease down your sink. As the grease cools it attaches itself to the walls of the sewer laterals. As time goes on and more grease is poured down the sink, the grease will continue to build-up until you could be faced with a blockage in your sewer lateral or in the sewer main. Using hot water to wash the grease down the drain only causes the grease to build up farther into the sewer lateral or into the sewer main. Grease should be collected in a metal container and allowed to cool and solidify prior to throwing it away in the normal trash. The following is a photograph of a lateral that is beginning to have a grease build up that could eventually lead to a blockage in the homeowners lateral.

Root intrusion causes slow drainage and can eventually lead to a blockage in the sewer lateral. Sewer laterals are usually made up of either vitrified clay, cast iron, or PVC pipe. Roots will generally grow into pipes where there is already a defect in the pipe. Over time, the tree roots can push their way into any cracks or the joints in the pipe. As the tree or shrubs grow, so do their roots. As the roots grow, they can move toward a source of water which could be in your sewer lateral. When considering where to plant trees or shrubs try to plant them away from the lateral. The further the distance of the tree or shrub, the better chance you may have to not encounter this problem. The following are examples of root intrusion in homeowner laterals.

Also, please keep in mind that objects such as toys, paper towels, disposable diapers, baby wipes, and cleaning wipes can also become clogged in your sewer lateral. Please do not flush these items down your toilet as they can become trapped in your lateral and, over time create a buildup that will clog the lateral resulting in a sewer back-up.

NO BURNING REGULATIONS

On August 3, 2010, the Perkiomen Township Board of Supervisors enacted Ordinance No. 207, an amended Recycling Ordinance. The amended Recycling Ordinance was a requirement of the Pennsylvania Department of Environmental Resources. One of the significant changes was the ban on burning. The Recycling Ordinance states that "No resident or person shall burn any recyclable material, leaf waste or municipal waste." UNATTENDED SPORTS EQUIPMENT

From November 1st to March 31st, Unattended Sports Equipment being left on or in close proximity of a township street is a violation of Perkiomen Township Ordinance No. 225.

Perkiomen Township requests owners of sports equipment to move the equipment far enough back from the curb or streets edge and outside of the street right-of-way during this timeframe to prevent damage from any township equipment performing winter maintenance and or spring cleanup of the streets. Damage can not only occur to the sports equipment, but to township and/or subcontractor equipment due to these objects being located either in the street or too close to the street.

The Township has the right to remove the unattended sports equipment without notice and without responsibility or liability for any damage caused thereto if left in a position in violation of the ordinance.
