2023 ANNUAL ROAD PROGRAM

PERKIOMEN TOWNSHIP - ROAD PROJECTS



DOES THE TOWNSHIP HAVE AN ANNUAL ROAD MAINTENANCE PROGRAM?

YES! Every year, Perkiomen Township invests in maintaining our Township owned Roadways. Perkiomen is responsible for 28.06 miles of roadway in accordance with PennDOT's Type 5 Map. The map identifies roads which are qualified for PennDOT Liquid Fuels Funding. Liquid Fuels Funding, commonly referred to as the "gas tax", is a tax on gasoline and oil franchises. These funds are provided to Municipalities based on their total length of roads to be maintained, under the Liquid Fuels Tax Act 655, and Act 89.



In implementing this program, the Township prioritizes which roadways are to be repaired based on their conditions in relation to all Township roads. There is priority in maintaining roads which are heavy traveled such as arterial roads or collector roads, versus local roads or cul-de-sac roads which may not have the same amount of vehicular traffic.



We invest most of our Liquid Fuels Funding into annual Road Projects. Such Road Projects may consist of the following: a roadway mill and overlay with new asphalt material; complete roadway reconstruction when roadways are in very poor condition; select base repair areas of localized failed asphalt areas; stormwater infrastructure upgrades; curb ramp upgrades; or microsurfacing. Such measures improve our roadway conditions. Based on our funding, typically 2-5 roads are improved depending on the length of the road and the cost of the type of repair.

We also maintain our roads through regular maintenance performed by our Township Road Crew. Such activities include: asphalt crack sealing; pothole / patching of failed asphalt areas; winter salting & plowing; storm inlet cleanings; leaf collection; installation of updated pavement markings; and street sweeping.



WHAT WILL THE PERKIOMEN TOWNSHIP 2023 ROAD PROJECTS CONSIST OF?

Perkiomen Township has selected to implement improvements on portions of Schoolhouse Road and Seitz Road as part of our 2023 Road Project. The awarded Contractor for the project is Innovative Construction Services, Inc., who has completed many of our Road Projects in the past.

Schoolhouse Road will be comprised of an 1.5-inch asphalt mill and overlay project (from Gravel Pike to just west of Greene Boulevard) with select base repair areas. This means the top 1.5-inches of asphalt will be removed, areas of base pavement failure will be repaired, and then a new 1.5-inch depth wearing course (i.e., also commonly called a top coat) will be installed.

Seitz Road (from Bridge Street to Raintree Circle) requires a full reconstruction, which is a much more intensive roadway repair. Based on roadway cores taken, the total asphalt depth in most of the road is only 5-inches of which the bottom 3-inches of material is beginning to degrade. To correct this, the road will be excavated to a 6-inch depth until we hit the stone subbase. 5-inches of base asphalt material, and 2-inches of wearing course material will then be installed and compacted. In order to reduce the impact of the road elevation on adjacent driveways, a crown in the roadway will be established. This is also known as roadway slope or pitch from the centerline of the road to the roadway edge. This results in a 2-inch increase at the center of the road, and only a 1-inch increase near the roadway edge. Affected driveways along Seitz Rd will be adjusted to ensure they contain smooth transitions.

Due to the extensive amount of work noted above, a **Road Closure and Detour** will be implemented. We anticipate this will last roughly one month. This detour is necessary due to the type of construction and the narrowness of Seitz Road. In an attempt to minimize disruption to our Residents, we plan to complete this project between late June and late August, and work toward avoiding the Perkiomen Valley School District (PVSD) school session.

We have provided a sample of the proposed detour for your information. All efforts will be made to communicate any changes to this detour through the Township's website.

* Take off lid, dry out paint, discard can without lid; or pour paint into plastic bag with absorbent material (clay based kitty litter, saw dust, rags) place bag and can without lid, in trash. Paint hardener can also be purchased at hardware stores.

DROP OFF GUIDELINES

- Montgomery County events are following state guidelines and public health restrictions.
- Leave items at home that are not for the event so that they are not removed accidentally.
- If you need your gas can or container returned, please tape a note to it stating that you want to keep it.
- You may arrive any time within your registered appointment window.
- Please print out your ticket or write your name and appointment time on a piece of paper.
- If you cannot attend the event, please cancel your appointment through your Eventbrite ticket or by emailing Recycling@MontgomeryCountyPA.gov, as others may be waiting for an opening.
- NO TVs, electronics, or appliances will be accepted.
- Event workers will unload your materials so please remain in your vehicle.
- **BUSINESSES AND CONTRACTORS WILL BE TURNED AWAY**, no commercial/industrial waste accepted.
- Bring all substances in original containers with labels. Items must be identifiable. Do not mix materials.
- Tighten lids on all containers. If containers are leaking, pack in larger container with newspaper to soak up leaks.
- NO 25- OR 50-GALLON DRUMS ALLOWED. Five-gallon buckets are the largest acceptable container. Maximum amount accepted per vehicle is 25 gallons or 220 pounds.
- There are no permanent drop off locations in the region for household hazardous waste, only the listed collections.

MONTGOMERY COUNTY RECYCLING INFORMATION

Electronic Waste

- Montgomery County has an agreement with “Retrievr” for electronic waste pick up and recycling which is available to all residents, see link <https://retrievr.com/location/montgomery-county-pa/>.
- Retrievr charges a flat \$10 doorstep pickup fee and convenience fees for the following items which are listed here and on the Retrievr webpage:
 - \$10 for each microwave
 - \$35 for each TV under 150 lbs. and monitors that use a Cathode Ray Tube (CRT)
 - \$100 for each TV 150 lbs. or more, such as those with wooden cabinets or rear-projection TVs
 - \$50 for each dehumidifier
 - \$50 for each window air-conditioner
 - \$50 for each mini refrigerator under 50 lbs.

PA DEP - MS4 Pollutant Reduction Plan “The Unfunded Mandate”

The PA Department of Environmental Protection (PA DEP) mandated that municipalities, including Perkiomen Township, need to maintain a Municipal Separate Storm Sewers Systems (MS4) permit. This permit requires municipalities to invest in, and promote, water quality within our PA Streams. Some municipalities are required to have a Pollutant Reduction Plan (PRP) in place as part of their permit based on various stream impairments. This plan is made over a 5-year cycle and requires municipalities to construct green infrastructure such as: stream restorations; basin retrofits; bioswales; rain gardens; underground infiltration beds; etc. Municipalities then must document that water quality requirements of the PRP plan were met by proving the installed green infrastructure achieves a 10 % reduction in sediment; a 5% reduction in total nitrogen (TN); and a 3% reduction in total phosphorus (TP).



Under the MS4 Program, Municipalities are not provided any direct funding from the PA DEP for the required engineering design of the PRP Plan; the design of green infrastructure; the land necessary for infrastructure; annual reporting; and the construction of any improvements. The entire MS4 program is mandated, such that municipalities cannot opt out; hence, the programs nickname “the unfunded mandate”.

To comply with our PRP requirement, Perkiomen Township has decided to pursue a 1,300 linear foot Stream Restoration Project, located off of Bridge Street (i.e., between West Birchwood and Fox Heath HOA’s. Streams with cliff like embankments with exposed sediment walls are major contributors to sediment within streams. Naturally, large storm events can cause embankment erosion and this erosion results in sediment being deposited into our streams. A Stream Restoration project attempts to reduce the severity of the steep embankments and stabilize the area by flattening the surrounding stream area and installing natural plants. These water quality improvements benefit the streams ecology, fish, and wildlife.

The Township awarded Flyway Construction, Inc. this Stream Restoration project in July of 2022 in the amount of \$466,800. The project is anticipated to begin construction in April of 2023 and last 3-4 months. This Stream Restoration project is projected to allow Perkiomen Township to meet its PA DEP MS4 Permit and PRP requirements in a single construction project.

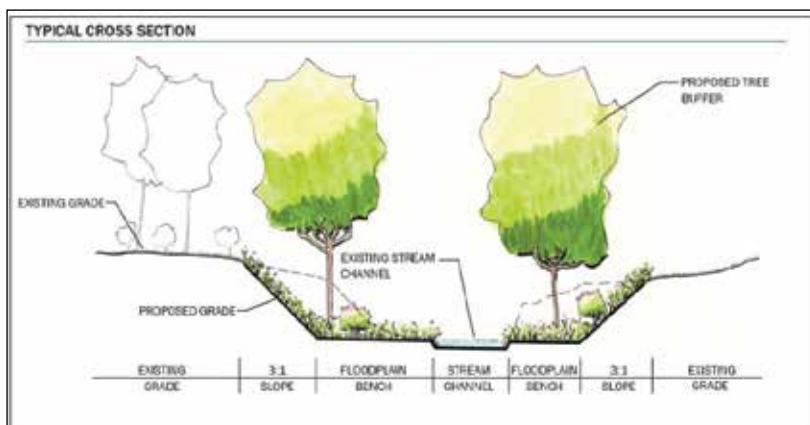
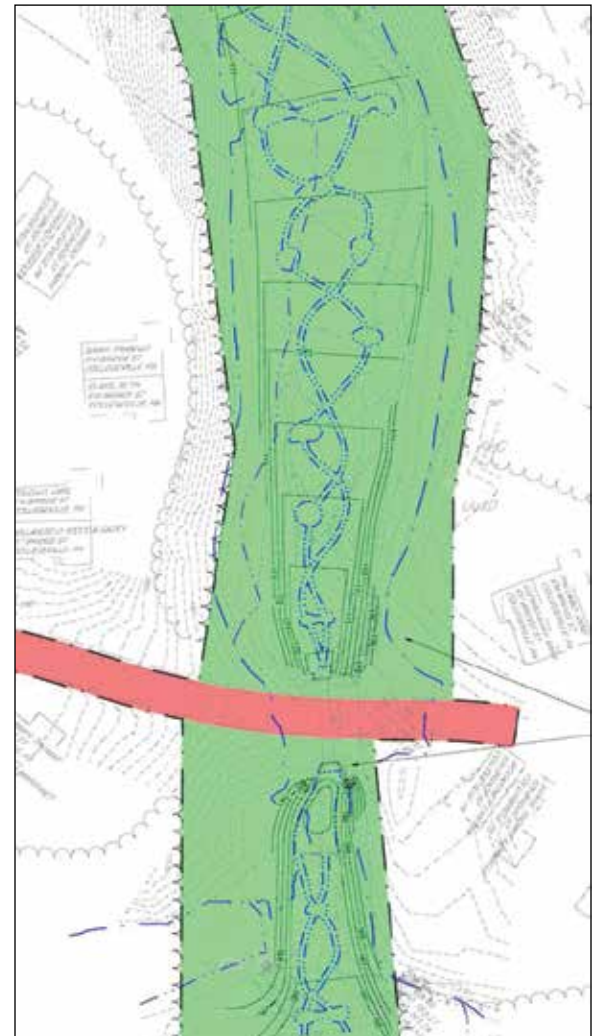
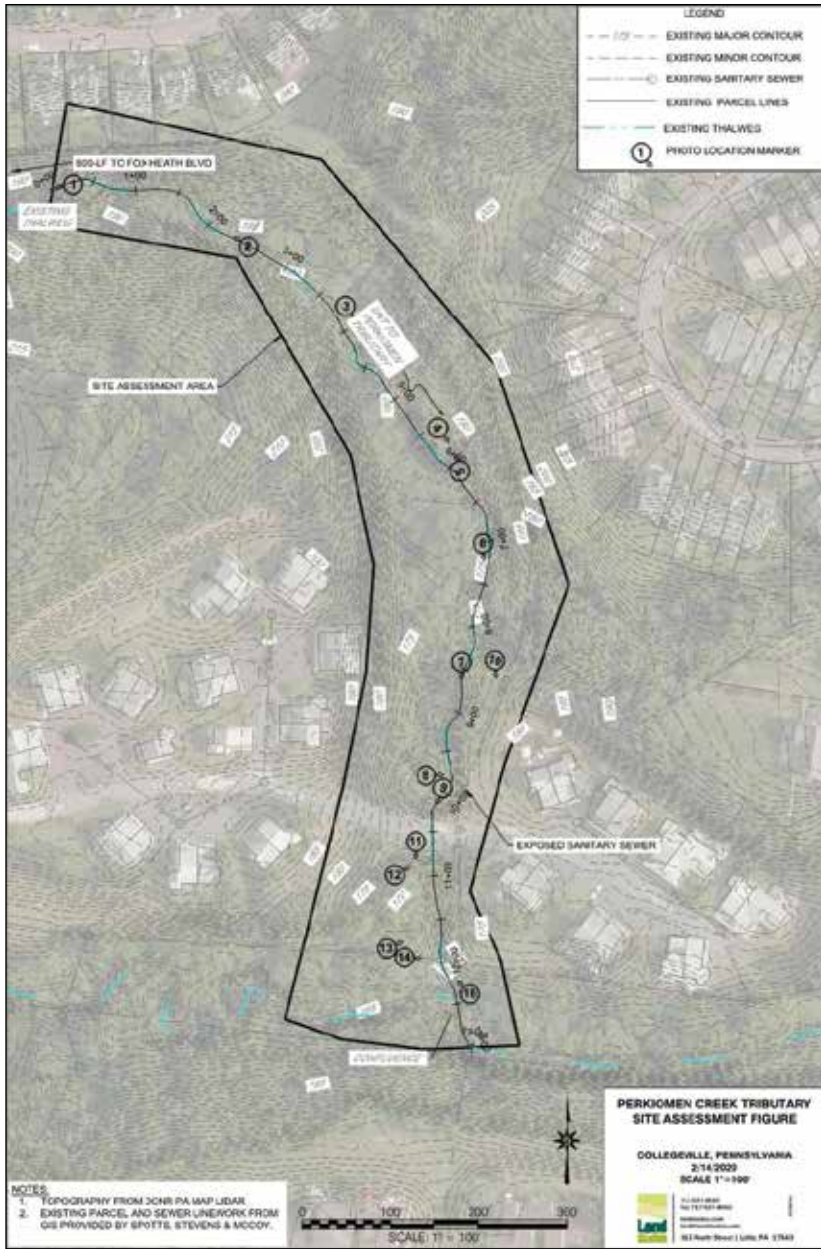
In order to fund this project, the Township pursued, and was awarded a \$200,000 grant from the MontCo 2040 Program, which is funded by Montgomery County. The remainder of the project will be funded by American Rescue Plan Act (ARPA).

The Township’s Environmental Advisory Committee is also continuing to explore other green infrastructure ideas, such as basin retrofits which convert traditional above ground grass basins into bio-retention basins which provide a water quality benefit. Such improvements would also assist the Township in meeting its PRP water quality requirements.

PERMIT REMINDERS!

Before you start your home projects, be advised permits may be required. Perkiomen Township issues Construction, Zoning, Plumbing, and Highway Occupancy Permits. Construction Permits are required for New Dwellings, Decks, Swimming Pools (both seasonal & permanent), Additions, and Structural Alterations. Zoning Permits are required for Sheds, Barns, Detached Garages, Gazebos, Fences, Patios, Home Occupations, No Impact Home Based Business, & In-law Quarters. Plumbing Permits are required for any plumbing work in which a Construction Permit is required. Highway Occupancy Permits are required for any new or altered driveway regardless of the material used. Although Perkiomen Township does not specifically require Electrical Permits, we recommend any electrical work be inspected by a Certified Electrical Inspection Agency for insurance purposes. Electrical work in which a Construction Permit is obtained is required to have the electrical work inspected as part of the Construction Permit.

In regards to Commercial Work, permits are required for any alteration or addition of space, even if the work is not structural, replacement of any equipment, i.e. electrical, mechanical, plumbing, or fire protection systems. Zoning Permits are also required for Signs.
