## **PERMIT REMINDERS!**

Before you start your home projects, be advised permits may be required. Perkiomen Township issues Construction, Zoning, Plumbing, and Highway Occupancy Permits. Construction Permits are required for New Dwellings, Decks, Patios with Footers, Swimming Pools (both seasonal & permanent), Additions, and Structural Alterations. Zoning Permits are required for Sheds, Barns, Detached Garages, Gazebos, Fences, Home Occupations, No Impact Home Based Business, & In-law Quarters. Plumbing Permits are required for any plumbing work in which a Construction Permit is required. Highway Occupancy Permits are required for any new or altered driveway regardless of the material used. Although Perkiomen Township does not specifically require Electrical Permits, we recommend any electrical work be inspected by a Certified Electrical Inspection Agency for insurance purposes. Electrical work in which a Construction Permit is obtained is required to have the electrical work inspected as part of the Construction Permit.

In regards to Commercial Work, permits are required for any alteration or addition of space, even if the work is not structural, replacement of any equipment, i.e. electrical, mechanical, plumbing, or fire protection systems. Zoning Permits are also required for Signs.

## **NO BURNING REGULATIONS**

On August 3, 2010, the Perkiomen Township Board of Supervisors enacted Ordinance No. 207, an amended Recycling Ordinance. The amended Recycling Ordinance was a requirement of the Pennsylvania Department of Environmental Resources. One of the significant changes was the ban on burning. The Recycling Ordinance states that "No resident or person shall burn any recyclable material, leaf waste or municipal waste." ## **REAL ID DEADLINE IS APPROACHING: OCTOBER 1, 2021**

#### What Is REAL ID?

REAL ID is a federal law that affects how states issue driver's licenses and ID cards if they are going to be acceptable for federal purposes, such as boarding a domestic commercial flight, or entering a military installation or federal facility that requires ID.

Beginning October 1, 2021, Pennsylvanians will need a REAL ID-compliant license, identification card, or another form of federallyacceptable identification (such as a valid passport or military ID) to:

- Board domestic commercial flights.
- Enter a military base.
- Enter a federal facility that requires ID at the door.

#### Do I need a REAL ID to drive?

You do not need a REAL ID driver's license or identification card to do any of the following:

- Drive
- Vote
- Apply for or receive federal benefits for which you are entitled (Veterans' Affairs, Social Security Administration, etc.)
- Enter a federal facility that does not require an ID (i.e. a post office)
- · Access a hospital or receive life-saving services
- Participate in law enforcement proceedings or investigations (serve on a federal jury, testify in federal court, etc.)

#### Why would I want a REAL ID?

A <u>federally accepted identification</u> (whether it's a Pennsylvania REAL ID driver's license or identification card, U.S. Passport/ Passport Card, military ID, etc.) must be used as your identification to board a commercial flight or visit a secure federal building **on and after October 1, 2021**.

If you want to use your Pennsylvania driver's license or photo ID as identification for these purposes, you may want to consider getting a REAL ID. Our <u>REAL ID online wizard</u> may help you decide if and when to get a REAL ID. If you know you will not be boarding a commercial flight or visiting a secure federal facility or military base after October 1, 2021 or if you have a valid passport, you do **not** need a REAL ID.

#### Where will I be able to get a REAL ID?

REAL ID's are available now. Customers who want a REAL ID have three options to obtain one:

- <u>Apply online</u> (pre-verified non-CDL customers only)
- <u>Visit any PennDOT Driver License Center</u> to have your documents verified and imaged, and receive your REAL ID within 15 business days
- Visit a REAL ID Center to have your documents verified and imaged and receive your REAL ID at the time of service

Please note that standalone photo centers are NOT able to perform REAL ID transactions, per federal regulations.

#### How much does the REAL ID cost?

You will pay a one-time fee of \$30, plus a renewal fee (current renewal fee is \$30.50 for a four-year non-commercial driver's license or a photo ID). The expiration date of the initial REAL ID product will include any time remaining on your current license or ID card, plus an additional four years, unless you are over 65 and have a two-year license.

This expiration date structure means that you won't "lose" time that you've already paid for. After the initial REAL ID product expires, the customer will pay no additional fee, beyond regular renewal fees, to renew a REAL ID product.

#### Maiden Name Changes

If your full legal name has changed as a result of marriage and is not reflected on your proof of identity document (birth certificate or passport), then you must show legal documentation of the change.

Please note that marriage certificates will ONLY be accepted if they are:

- Originals or certified copies (no photocopies)
- Issued by a county court

Commemorative marriage certificates signed by a clergyperson or other officiant are NOT acceptable for REAL ID.

 Install a rain barrel. Rain barrels are containers that attach to your downspout and collect rainwater from your roof. They provide free water for you to use to water your plants!



2) Start composting! Pre-made compost tumblers are a great option for a small yard. Not only does composting reduce waste, but adding compost to your soil helps with stormwater infiltration.

3) Install permeable pavers instead of traditional concrete or asphalt. Permeable pavers are designed to allow rain water to seep back into the ground before it can become runoff.



4) Wash your car at a car wash. Most car washes reuse the wash water before sending it to a treatment plant. If you want to wash your car at home, wash it on gravel or grass.

\* Take off lid, dry out paint, discard can without lid; or pour paint into plastic bag with absorbent material (clay based kitty litter, saw dust, rags) place bag and can without lid, in trash. Paint hardener can also be purchased at hardware stores.

## **DROP OFF GUIDELINES**

- BUSINESSES AND CONTRACTORS WILL BE TURNED AWAY, commercial/industrial generated hazardous waste will not be accepted.
- Bring all substances in original containers with labels. Items must be identifiable. Do not mix materials.
- Gas containers returned upon request.
- Tighten lids on all containers. If containers are leaking, pack in larger container with newspaper to soak up leaks.
- Maximum amount accepted is 25 gallons or 220 pounds. A five-gallon bucket is the largest acceptable container.
- Event workers will unload your materials so please remain in your vehicle.
- There are no permanent drop off locations in the region for household hazardous waste, only the listed collections.

## **For Voters**

#### **Mail-In Voting**

**You may now vote by mail-in ballot**, unless you qualify as an absentee voter, in which case you must vote by absentee ballot. If you want to vote by mail you must apply for a mail-in ballot. You do not need to provide a reason or excuse if you want to use a mail-in ballot. The county must receive your application for a mail-in ballot by 5:00 p.m. on the Tuesday before the election.

You can return your voted mail-in ballot by mailing it to your county board of elections using the envelope provided, or you can drop it off in person at the board of election's office. Whichever way you choose, the County must receive your voted ballot by 8:00 p.m. on election day in order for it to be counted.

**You may also ask to be placed on a permanent mail-in voter list. If you are on this list,** you will have a mail-in ballot application mailed to you by the first Monday in February each year. If you complete and return the application, the county will send you ballots in the mail for all the elections that take place that year, as well as for any special election held through the third Monday in February of the next year. For example, if you return your completed mail-in application in February 2020, you will automatically receive a ballot for the April 28, 2020, Primary and the November 3, 2020, General Election, as well as ballots for any special elections held on or before February 15, 2021.

ounts

If you are sent a mail-in ballot and the county receives your voted ballot by the deadline (8:00 p.m. on election day), you may not vote at your polling place. Your vote is considered final at that point. However, if you mailed your ballot too late, or you aren't sure whether the county received your voted ballot in time, you may be able to vote a provisional ballot at your polling place. If you were sent a mail-in ballot, but your polling place has no record of having received it, you may vote by provisional ballot. However, if the county does receive your voted mail-in ballot in time, that ballot, not your provisional ballot, will be counted. **Remember**, **you may always return your mail-in ballot at the county board of election's office by 8:00 p.m. on election day**.

Finally, **counties are authorized to begin processing mail-in applications more than 50 days before the election.** Beginning 50 days before the election, counties must begin transmitting mail-in ballots as soon as the ballot is certified and the ballots are available. Counties may await the result of a court proceeding that would affect the content of ballots before delivering mail-in ballots, but in any case, counties must begin to send out mail-in and absentee ballots no later than the second Tuesday before the election.

#### **Voter Registration Deadline**

The **deadline to register to vote is now 15 days before an election**, rather than 30 days. If your voter registration application is denied, the deadlines to appeal the decision have also changed.

#### **Absentee Balloting**

The **deadline for a county to receive a regular civilian absentee ballot is now 8:00 p.m. on Election Day.** Regular civilian absentee ballots received after this time will not be counted unless a Court has extended the deadline.

If you are sent a regular civilian absentee ballot and the county receives your voted ballot by the deadline (8:00 p.m. on election day), you may not vote at your polling place. Your vote is considered final at that point. However, if you mailed your ballot too late, or you aren't sure whether the county received your voted ballot in time, you may be able to vote a provisional ballot at the polling place. If you were sent a regular civilian absentee ballot, but your polling place has no record the ballot was voted and received, you may vote by provisional ballot. However, if the county does receive your voted ballot in time, that ballot, not your provisional ballot, will be counted. **Remember, you may always return your absentee ballot at the county board of elections office by 8:00 p.m. on election day**.

The process for obtaining an emergency absentee ballot has been simplified. More than one voter may now designate the same person to deliver their ballot. For example, the same hospital employee may deliver ballots for multiple patients.

**Counties must now process absentee applications beginning 50 days before the election.** Counties may wait for the result of a court proceeding that would affect what's on the ballots before delivering absentee ballots. In any case, counties must begin, at the latest, to deliver absentee ballots by the second Tuesday before the election.

**Finally, if you have a permanent disability, you may ask to be placed on a permanent absentee voter list.** If you are on this list, you will have an absentee ballot application mailed to you by the first Monday in February each year. If you complete and return the application, the county will send you ballots in the mail for all the elections that take place that year, as well as for any special election held through the third Monday in February of the next year. For example, if you return your completed absentee application in February 2020, you will automatically receive a ballot for the April 28, 2020, Primary and the November 3, 2020, General Election, as well as ballots for any special elections held on or before February 1, 2021.

## **SWIMMING POOL PERMITS**

As summer is rapidly approaching and temperatures and humidity start to soar, people are looking for ways to keep cool. One way people are dealing with the heat is the purchase of these relatively inexpensive portable/storable on-ground pools that are seen on this page. These pools can be purchased at almost every big box retail store around.

The Pennsylvania Uniform Construction Code (UCC) and International Swimming Pool and Spa Code (ISPSC) define a Swimming Pool as a pool intended for use, which is accessory to a residential setting, and available to the household and its guests. This includes in-ground, above-ground, and on-ground swimming pools.

INTE

Although they are storable and can be taken down at the end of the season, these pools are regulated by the UCC, and enforced by Perkiomen Township. A one-time building permit is required and compliance with the ISPSC shall always be maintained while the pool has water in it and upon a property in Perkiomen Township.

> Although a permit will not be required every season for the pool, the barrier shall still meet the adopted code requirements. These Barrier Requirements are intended to provide protection against potential drowning's and near-drowning's by restricting access to the swimming pools.

> > Property owners who fail to obtain a permit for these pools may face a fine of up to \$1000.00.

## ADDRESS NUMBERS

Are your address numbers visible for emergency services? No one knows when an emergency will occur and having your address visible can save precious time for emergency services in finding your home. Perkiomen Township, through its Property Maintenance Code, requires that address numbers be plainly visible and legible from the street or road fronting the property. The ideal place for address numbers is on both sides of the mailbox or post fronting the property. In cases where there is no individual mailbox, the numbers should be put on an exterior surface on the front of the home or on a stake in the front yard adjacent to the street. Address numbers shall contrast with their background and be of a minimum size of 4 inches in height.



## **TOWNSHIP-WIDE SURVEY RESULTS**



In 2019, the Board of Supervisors conducted a Townshipwide survey. The survey covered the following topics: Police, Open Space/Parks, Environmental Advisory Council, Township Wide Trash Collection, and Roads. The following is a summary of the findings, based upon the responses received:

#### **POLICE COVERAGE:**

From the responses received, the majority felt satisfied with the police coverage that the Township receives from

the PA State Police. At the present time, Perkiomen Township does not pay any fee to the Commonwealth for this coverage. Over the last couple of years, there have been different attempts by the Governor and Legislature to change that. There was a question on the survey that asked whether the Board should consider other options if this should change. The responses from the majority indicated other options should be considered if the State starts charging municipalities for State Police coverage.

#### **OPEN SPACE/PARKS:**

The majority of responses favored the continuation of the existing Open Space Tax and to continue purchasing land for open space as it becomes available. Regarding the issue of what to do with open space the Township already owns, the responses included such things as leave the property undeveloped, put in trail connections, walking paths, pavilions, rain gardens, dog parks or nature-inspired playgrounds.

#### **ENVIRONMENTAL ADVISORY COUNCIL:**

The majority of responses indicated the desire to create an Environmental Advisory Council. This Council would work with the Board on such issues as rain gardens, storm water runoff, and Municipal Separate Storm System (MS4) requirements/compliance. This Council will also collaborate with the Planning Commission and the Park and Recreation Committee in dealing with environmental issues within the Township.

#### **TRASH COLLECTION:**

Currently, there are a number of trash haulers serving the Township. Survey responses indicated that residents are aware of the damage these heavy trash trucks cause to Township roads. The majority of those responding favored the Township considering contracting with a single hauler. Choosing a single hauler would not only reduce the damage done to Township roads but would also provide reliable pricing on trash collection and recycling. Trash collection by a single hauler would require the bidding out of these services, and the selection of the lowest responsible bidder, which all Township residents would be required to use.

#### **ROADS:**

On the response to the conditions of the Township roads, the majority of those responding indicated that they are satisfied with the condition of our roads.
