**PERKIOMEN TOWNSHIP PAVILION RENTAL RULES AND REGULATIONS**

- All Perkiomen Township Parks and Recreation Rules and Regulations shall remain in effect throughout the duration of the rental. (Copy Attached) When deemed necessary, the Township may impose special or additional rules, regulations, and restrictions.
- The rental of the Pavilion is not complete until the Township receives the completed form and required check. All information shall be provided on this form and it must be signed below. The form is located on the Township’s website: [www.perkiomentownship.org](http://www.perkiomentownship.org)
- **PLAYGROUND IS NOT RESERVED BUT IS AVAILABLE FOR YOUR USE.**
- A \$50.00 non-refundable rental fee is required.
- Registration must be done in person, at the Township office, at least one (1) week in advance.
- The Pavilion is intended to be used by Township residents and any service organization located within the limits of the Perkiomen Valley School District.
- The Pavilion will **not** be rented to residents outside the Township.
- The Pavilion shall not be used for commercial purposes.
- All facilities will close at 10:00 p.m.
- **Parking is restricted to designated parking spots ONLY. Parking on a walking path or on the grass is strictly prohibited and will affect the ability to rent the pavilion in the future.**
- Do **NOT** attach anything with nails, tacks or staples to pavilion poles, picnic tables, etc.
- At the conclusion of your event, the Pavilion must be cleaned and all trash put in the proper containers.
- If any Pavilion property is damaged during your rental, you will be responsible for the cost of required repairs and/or replacement.
